

## COMPETITION WINNER QUESTIONNAIRE

### **FOR U.S. RESIDENTS ONLY:**

As a condition to the payment of any prize to a contest winner, the winner must provide Zooppa.com, Inc. with a properly completed and executed Internal Revenue Service Form W-9 and such other documents and information that Zooppa may reasonably request to comply with all applicable laws and tax reporting and withholding obligations. A contest winner's failure or refusal to satisfy this condition could (in Zooppa's sole discretion) result in forfeiture of his or her prize(s). Contest winners may receive an IRS Form 1099.
